## **The type of personal information we collect**

We currently collect and process the following information:

- Name, contact details and messages
- Name and testimonial

## **How we get the personal information and why we have it**

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- For communication purposes
- For testimonial purposes

We use the information that you have given us in order to be able to offer services to you.

For the reason of offering services to you we may share this information with Triple B.V. and subsidiaries of Triple B.V..

Under the European Union General Data Protection Regulation (EU GDPR), the lawful basis we rely on for processing this information is your consent. You are able to remove your consent at any time. You can do this by contacting Jaap Krekel Schuit, Jaap@jaapkrekelschuit.com

## **How we store your personal information**

Your information is securely stored. We keep your name, contact details, and messages no longer than necessary. We store your personal data in the mail database (deleted after 4 weeks latest), personal data is also disposed after the withdrawal of your consent.

We keep your name and testimonials for a maximum of; 4 weeks in the mail database, after which we delete the information; 5 years on the website, after which we anonymize the information; 10 years in our portfolio, after which we anonymize the information. Personal data is also disposed after withdrawal of your consent.

## **Your data protection rights**

Under data protection law, you have rights including:

**Your right of access** - You have the right to ask us for copies of your personal information.

**Your right to rectification** - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

**Your right to erasure** - You have the right to ask us to erase your personal information in certain circumstances.

**Your right to restriction of processing** - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

**Your right to object to processing** - You have the the right to object to the processing of your personal information in certain circumstances.

**Your right to data portability** - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
